How long does it take to get moved into a rental home?

The relocation process starts immediately. As the housing staff locates rental options, they will be sent to you with contact information, maps, and directions from your home to the rental. It is important to view the options provided as quickly as possible. Once you have decided on a rental home, the process of moving you in will typically progress within 24 to 48 hours.

Where do I stay in the meantime?

From the day of your loss until you choose a rental home, you have the option to stay with friends, family or in a hotel. Depending on the length of your home repairs, it's better to choose a comfortable home versus a smaller hotel room.

How are temporary housing payments made?

What to expect

CRS finds you temporary housing



We begin looking for temporary housing as close to your damaged residence as possible. Our goal is to find you a property to view within 24 hours, accommodating pets and satisfying any special needs.

CRS handles your lease



We facilitate the lease to meet your insurance policy requirements, including an option to extend the rental month-to-month, when possible.

CRS arranges your walk-through



After your CRS representative locates a property that matches your needs, we will make arrangements for you to walk-through and tour the property.

CRS requests rental furniture



Arrangements for furniture and/or housewares will be made, if the need exists.

CRS handles all the paperwork



Working within your policy requirements, CRS submits the temporary housing costs and details to your insurance adjuster for approval.

CRS moves you in



Your CRS representative begins the move-in process, which includes: delivery of furniture and housewares, hook-up of utility/phone service, and arrangement for any additional services.

CRS moves you out



We contact you 30-45 days before your lease expires, schedule the move-out date, initiate the move-out notice, and schedule the pick-up of all items.
